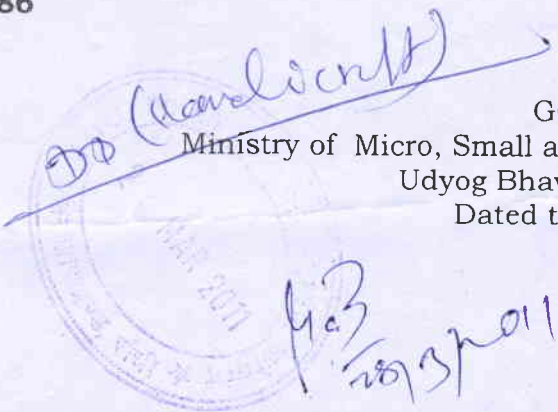
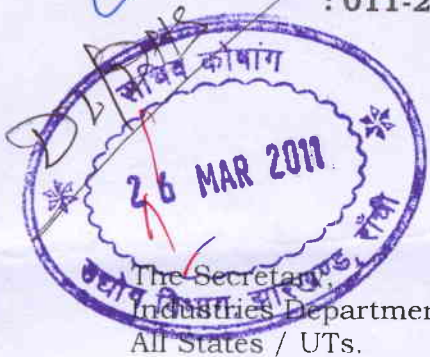


As you are aware, Khadi and Village Industries Commission (KVIC) is a statutory organization set up under KVIC Act, 1956 for promoting and developing khadi and village industries, inter-alia with a view to providing employment opportunities in rural areas and strengthening the rural economy. KVIC is one of the major organizations in the decentralized sector for generating sustainable employment opportunities in rural non farm sector at low per capita investment with a view to checking the migration of rural population to urban areas in search of employment. KVIC reports to the Ministry of Micro, Small and Medium Enterprises, Government of India as its administrative Ministry.

2. The section 4 of the KVIC Act provides for 10 non-official members in the Commission. The 10 Non-official Members include 6 Members having specialized knowledge and not less than 10 years of experience of khadi or village industries and representing 6 geographical zones of the country as prescribed under Rule 3 of the KVIC Rules, 2006. An extract from the Rules identifying the six geographical zones of the country and the states included therein is attached as **Annexure-I**.

3. I am directed to say that the present term of the Khadi and Village Industries Commission(KVIC) is expiring on 18th July, 2011. The Government is in the process of reconstituting the Commission.

4. You are, therefore, requested to send to this Ministry immediately, in any case not later than 28th February, 2011, the names of five eminent persons who fulfill the criteria of specialized knowledge and not less than 10 years of experience of khadi and village industries alongwith their bio-data indicating, inter-alia, the name, date of birth, qualification, their occupation and experience in the field of Khadi and Village Industries, for consideration of the Government for appointment as a Part-time Member of the Commission.

ANNEXURE-I

List of six geographical zones of the country and states included therein

- (i) **Northern Zone** : States of Haryana, Himachal Pradesh, Jammu and Kashmir, Punjab, Rajasthan, National Capital Territory of Delhi and Union territory of Chandigarh;
- (ii) **North-Eastern Zone** : States of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram , Nagaland, Sikkim and Tripura;
- (iii) **Central Zone** : States of Madhya Pradesh, Chhattisgarh, Uttar Pradesh and Uttaranchal;
- (iv) **Eastern Zone** : States of Bihar, Orissa, Jharkhand, West Bengal and Union territory of Andaman and Nicobar Islands;
- (v) **Western Zone** : States of Gujarat, Maharashtra and Goa and Union territories of Daman and Diu and Dadra and Nagar Haveli;
- (vi) **Southern Zone** : States of Andhra Pradesh, Karnataka, Kerala and Tamil Nadu and Union territories of Pondicherry and Lakshadweep.

An Extract of Section 4 of the KVIC Act, 1956

Establishment and Constitution of the Commission

4.(1) With effect from such date as the Central Government may, by notification in the Official Gazette, fix in this behalf, there shall be established a Commission to be called the Khadi and Village Industries Commission which shall be a body corporate having perpetual succession and a common seal, with power to acquire, hold and dispose of property and to contract, and may by the said name sue and be sued;

(1A) Save as otherwise provided under this Act and the rules made thereunder, the exercise of all powers and discharge of all functions under this Act, including general superintendence, direction and management of day-to-day affairs of the Commission, shall vest in the Commission.

(2) The Commission shall consist of the following members appointed by the Central Government, namely:-

(a) **six non-official members** [having specialised knowledge and not less than ten years of experience of khadi or village industries] and representing such six geographical zones of the country, as may be prescribed;

(b) **four non-official members** of whom each member shall be from the following disciplines, namely:-

(i) one member having expert knowledge and experience in *Science and Technology*;

(ii) one member having expert knowledge and experience in *Marketing*;

(iii) one member having expert knowledge and experience in *Rural Development*; and

(iv) one member having expert knowledge and experience in *Technical Education and Training*;

(ba) the Chairman of State Bank of India constituted under sub-section (1) of section 3 of the State Bank of India Act, 1955 or an officer not below the rank of the Deputy Managing Director as may be nominated by the Chairman of the State Bank of India - *ex-officio*;

(c) a Chief Executive Officer, *ex-officio*; and

(d) a Financial Adviser, who shall also be the Chief Accounts Officer of the Commission, *ex-officio*.

(3) The Central Government may appoint one of the members appointed under clause(a) of sub-section (2) to be the Chairman who shall be a full time member.
